ANVISA: SNCM Expected to Start Immediately as a Priority Project



On July 7, Brazil's national health regulatory agency, ANVISA, **assigned priority status** to the development and implementation of the country's National Drug Control System (SNCM), delivering a clear message to pharmaceutical companies that they will be expected to keep pace with the agency's **aggressive series of milestones** beginning in December 2020.

As ANVISA finalizes its Normative Instructions and Technical Guidelines for meeting Brazil's product serialization and track-and-trace regulations, integration with the agency's reporting system, SNCM, will be a critical focus for both domestic and multinational manufacturers in the weeks and months ahead. In addition to "vertical integration" with SNCM, each company must also implement "horizontal" peer-level data exchange to ensure that their supply chain partners have accurate product and aggregation data for SNCM reporting.

With the first deadline less than 6 months away, you need to start now.

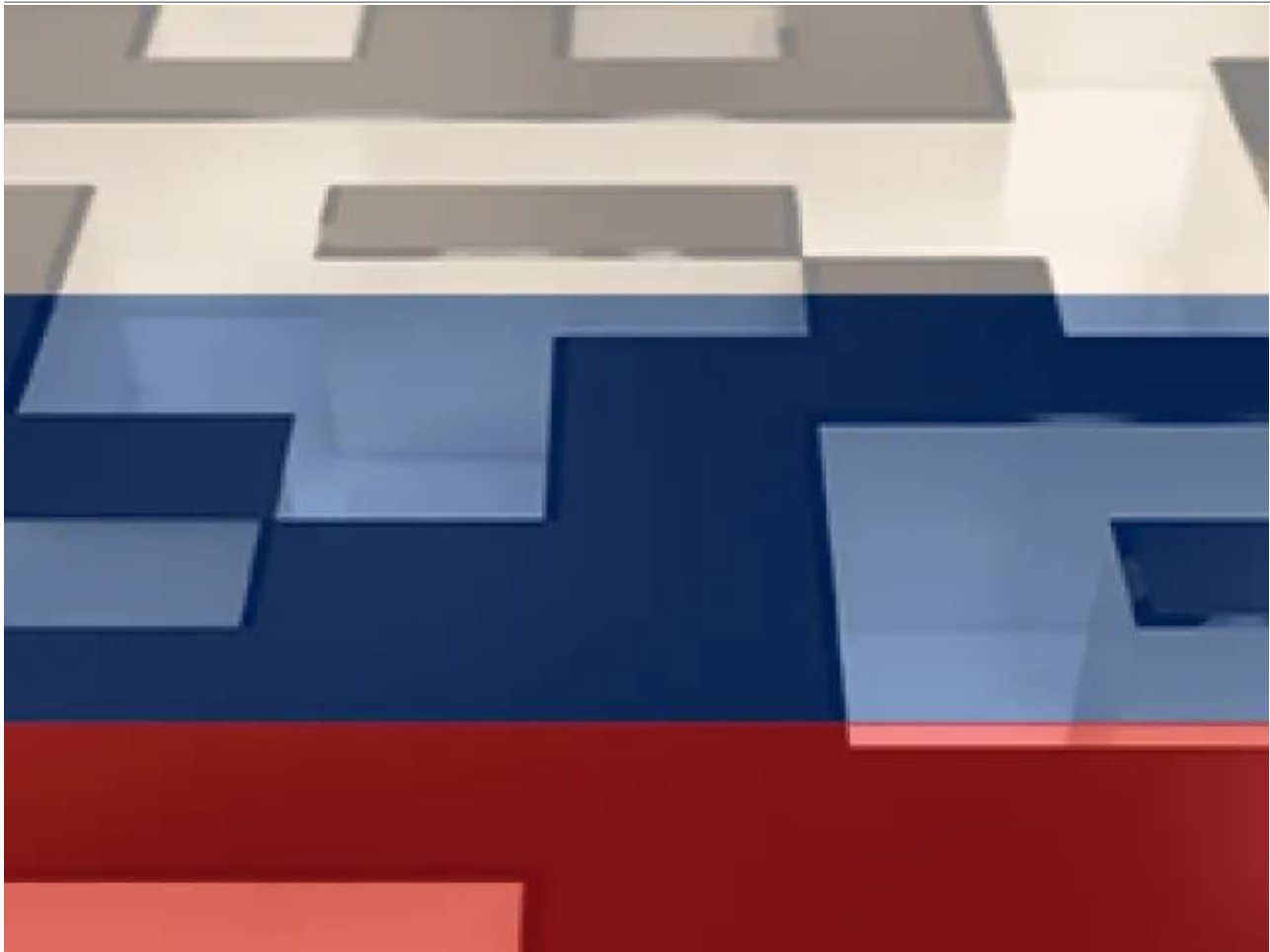

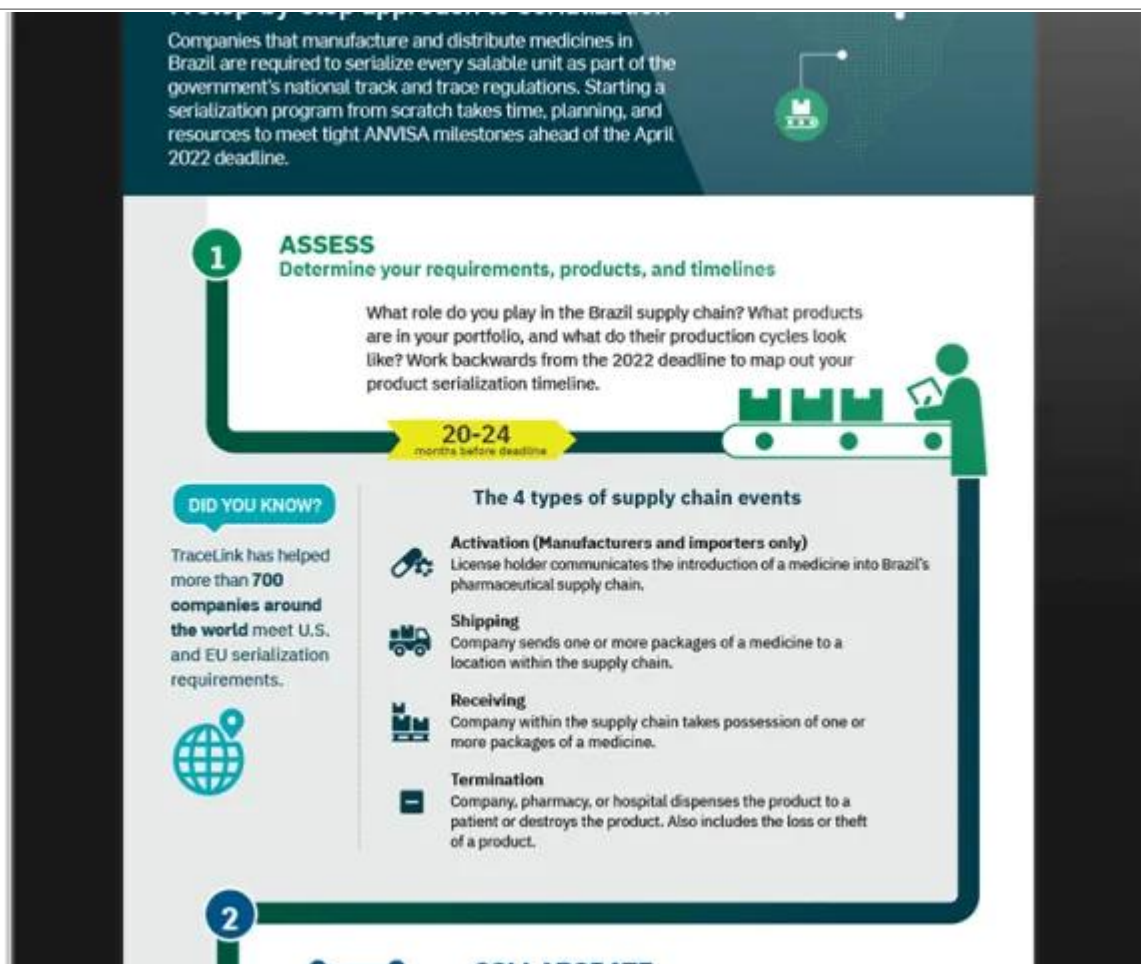
