Under the final phase of the **U.S. Drug Supply Chain Security Act (DSCSA)**, pharmaceutical manufacturers and their supply chain partners have until November 27 to implement a 100% electronic and fully interoperable system for product identifier verification for saleable returns and suspect/illegitimate product investigations. This requirement coincides with the requirement to exchange serialized product data and the trade partner requirement for GTIN and other product master data sharing. TraceLink partnered with industry leaders in 2017 to collectively design what is now called the Verification Router Service (VRS) network model for managing DSCSA and supply chain verification needs. Since then, over 160 companies have deployed TraceLink for verification capabilities, including flexible support for Level 4 serialization repositories that are managed by TraceLink or other solution providers such as SAP, Antares/Rfxcel, Systech, and

others.

Recently, at least one VRS vendor has indicated a change in market strategy that may reduce viability for existing customers. As a result, many pharmaceutical companies are rapidly exploring alternative approaches for supporting this requirement, in addition to adjacent needs for EPCIS data exchange, product status distribution, GTIN/product master data sharing, dropship information sharing, and compliance exception management.
