# Quick reference for network and app names

The networks in the network composer and the apps in the main menu display in alphabetical order. If a network name appears more than once in the quick reference table, that means all apps with that network name listed are accessed from that network.

# **Company names**

All Partner network names are prefixed by the name of the company that owns the network (e.g. Kendall Pharma - Serialized Operations Manager).

# **Classic TTS apps**

All classic TTS apps are available through the main menu. Some networks include both OPUS Web UI screens *and* classic TTS Web UI screens.
