DSCSA Readiness Alert: Wholesale Distributors, Your August 27 Deadline Is Here—TraceLink Is Ready to Help



August 27: Game On for Distributors

The U.S. pharmaceutical supply chain is entering a defining moment. On August 27, 2025, the FDA's stabilization period ends for wholesale distributors, requiring full compliance with the enhanced drug distribution security (EDDS) provisions of the DSCSA. From this date forward, distributors must exchange package-level product tracing data electronically, verify serialized product identifiers through interoperable systems, and manage exceptions and saleable returns digitally and securely. For distributors, this marks the shift from preparation to execution — ensuring serialized, electronic data flows through the very heart of the supply chain. For those not yet ready, the compliance and business risk has now ramped up.

This milestone follows the expiration of the stabilization period for manufacturers and repackagers in May 2025, and it precedes the requirement for dispensers to comply by November 27, 2025. Smaller dispensers will follow in November 2026. Together, these phased deadlines are synchronizing every segment of the supply

chain on a common foundation of electronic, package-level traceability designed to protect patients and build a stronger, more resilient distribution system.
